- ❑ Attending a 2- or 4-year college/technical school in the fall of 2024

PLEASE SUBMIT THE FOLLOWING WITH YOUR APPLICATION

- ❑ Unofficial high school transcripts
- ❑ Letter of acceptance to college or technical institution
 - Or letter of intent with acceptance letter provided before disbursement of funds.
- ❑ A brief 100- to 300- word essay describing why the student is deserving of a TruStar-sponsored scholarship. Students are encouraged to include their volunteer activities, plans for a major in college (if known) and career aspirations.

The TruStar Federal Credit Union Scholarship Committee will process applications and make selection-related decisions. All decisions are final. Award money will be sent directly to the school. If any student chooses not to enroll in college for any reason, an alternative recipient will be chosen.
